# TUITION

### **REGISTRATION FEE**

Tuition is divided into equal monthly payments and is the same regardless of how many lessons are in a month. Studio closures for calendar holidays and breaks are figured into tuition rates. There are no refunds for missed classes or dropping without proper written notice. Tuition is non-refundable and non-transferable.

- Dance families: First month and last month's tuition are due upon registration, as well as a family registration fee.
- Music families: First month's tuition and family registration fees are due upon registration.

# DISCOUNTS

Students taking more than one dance class are eligible for our Multi-Class Discount.

- 1st Class per Student: Full Price
- 2nd Class for Same Student: 10% Off
- 3rd Class and Beyond for Same Student: 15% Off

\*Discount is not valid for mini-session classes.

# **MONTHLY TUITION**

Tuition is posted MONTHLY and your balance is automatically deducted from your bank account or card on the 1st of every month. You may receive an email receipt to review, but no action will be necessary.

# LATE FEES & NSF FEES

Arts in Motion charges a \$25 late fee to all payments received after the 10th of the month. Late fees compound monthly. Any declined payments or returned checks will incur a \$20 NSF fee. AiM has the right to suspend a student if the account balance is over 30 days delinquent or if consistent delinquent payments on accounts are received. AiM also reserves the right to prohibit a family from purchasing tickets or a student from participating in performances if the account is past due.

# **CLASS CANCELLATIONS & REFUNDS**

Arts in Motion makes every effort to hold each class offered. In the event that a class does not reach the minimum number of students or the number falls below that minimum, AiM reserves the right to cancel or combine any class at any time. If such an instance should occur, you will be notified and we will discuss suitable alternatives. If none can be agreed upon, AiM will refund any tuition payments in full. If the class has already begun, AiM will refund tuition for unused classes. We do not give refunds, credits, pro-rations, or discounts for any other reason, including but not limited to illness, injury, vacation, inclement weather, loss of power or ventilation, or other circumstances beyond our control. You are liable for tuition regardless of whether your child is in attendance as your child's spot is being reserved until you complete the appropriate Withdrawal Form. If your child is absent, we will help you choose and schedule a makeup session in another appropriate class.

### **CLASS WITHDRAWALS**

Arts in Motion allows class withdrawals with a 30-day written notice using our Withdrawal Form. This allows us time to open up your spot to a new student. Email, phone, and verbal withdrawals will not be honored. All accounts must be paid in full in order to withdraw from classes.

*For Dance Students:* Your pre-paid final month's tuition will be applied towards your last month of classes as long as your account is in good standing. We do not issue pro-rated refunds of any unused tuition or classes, except in the case of class cancellation by AiM. No withdrawals are permitted for school year session classes after March 1st.

*For Music Students:* Thirty-days written notice is required using our Withdrawal Form, as well as payment through your final 30 days of lessons.
